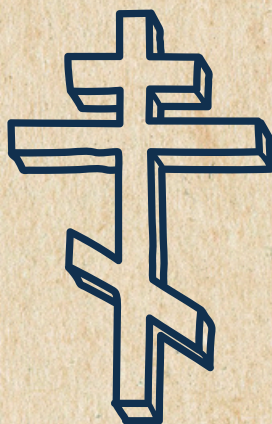

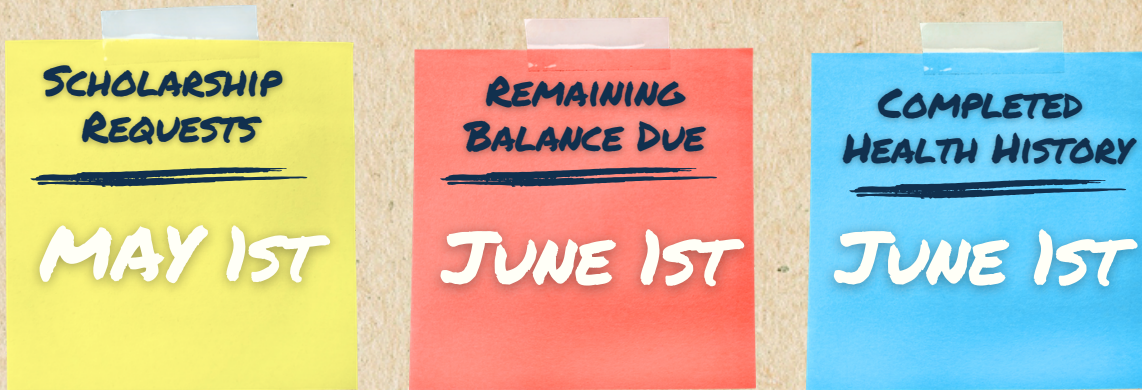

# CANCELLATION POLICY & IMPORTANT DEADLINES

## Cancellation & Refund Policy

Cancellations before June 1st receive a full refund less the \$75 deposit. After June 1st, refunds of tuition payments may be requested in writing and will only be granted if a replacement for the open spot is found, except for family emergencies (not family choice). For families who have been awarded scholarships - if cancelling after the June 1<sup>st</sup> deadline for reasons outside of family emergency, families will not be eligible to receive a scholarship for the following summer camp session. The deposit is non-refundable and non-transferable.



\*Failure to complete the online health form by the due date will result in a \$50 fee due prior to admission to camp. Please note that we cannot admit any camper to camp who has not completed all of the health forms and signed the terms and permission to treat.

# Prior to Camp

## ARRIVAL AND DEPARTURE

Camp begins on Sunday and registration is from 3:30 pm to 4:30 pm. Early arrivals are discouraged as we will not be accepting campers prior to this window. No camper can be dropped off until they have been checked in to camp. Campers may not drive themselves to camp as adult must check them in and there is no parking available to campers. Please make sure that your camper eats lunch prior to arrival and make every effort to arrive no later than 4:30 pm. If you have a first-time camper, you may want to arrange to arrive with enough time to meet your camper's counselor, tour the camp, etc.

**Camp ends on Friday at 12 pm.** We request that parents pick up campers promptly as our facility contract requires us to vacate the facility at a specific time. Please keep in mind that all staff are volunteers who have devoted an entire week to providing a memorable experience for your camper. Please be courteous and make every effort to ensure that your camper is picked up in a timely manner so that staff does not have to make special arrangements for late pickups as many staff members have traveled a long way. There will be a \$75 fee per camper applied to your account if you are late and special arrangements need to be made for offsite pickup (this does not apply to extreme emergencies). Campers may not drive themselves to camp.



## **Check-In Process**

As you arrive at camp, please park in the designated area of the main parking lot and follow signs to check-in located inside the Aldersgate auditorium where volunteers will be waiting to assist you. During check-in you will be asked to provide the name of the person who has your authorization to pick up your camper on departure day. If your camper is carpooling with another family, please make sure to print and complete the Health Screen Form on the morning of camp and send it with your camper to turn in at camper check in.

Your camper will then receive their cabin assignment, turn in any cell phones, (these will be returned upon check-out on Friday), have their medical history reviewed, turn in medications - prescription/OTC/supplements, and screening questions asked. Please note, campers will not be able to attend if they have a fever of 100.4 degrees or higher regardless of the reason.

After the health screening, campers will meet their counselor. The counselor will escort your camper (and parent if desired) to his/her cabin. Here, they will meet other campers as well as their second cabin counselor. At this point, parents are free to leave, and their campers are now in the care of their counselors and will begin their fantastic weekend at CSME!

### **Departure/Check-Out**

Camp officially ends at 12 pm on Friday. You will meet your camper in the same building as check-in. Your camper's counselor will have a sign-out sheet for the authorized pick-up person to sign. Your camper cannot be released until the counselor has verified the identity of the authorized person via a valid ID and they have signed the sign-out sheet. The counselor will then return any stored cell phones and, if medications/supplements were collected upon arrival, direct you to the medication retrieval table where medical staff will be stationed to return all medications.

Just about everything about life at camp is different from life at home! Preparing your camper with as much information as possible will help them to better adjust. Some key differences are - having a different daily schedule, sharing living quarters with others, and eating food that they may not be used to having at home. If you are sending a first-time camper, please review this section with them so they know what to expect.

# Camper Rules and Expectations

*Please read the following carefully and share with your camper(s).*

## Camper Code of Conduct

All campers are expected to act in ways appropriate to an Orthodox Christian setting and as those who seek to be living examples of Christ. Campers and staff alike comment year after year about the loving, positive, inclusive environment. Such an environment involves the commitment of each and every camper to follow the rules as outlined below. Failure to do so may result in a camper or staff member being sent home.



## Camp Rules

1. You will be expected to do as you are asked by those in authority, including the camp director, clergy, counselors, and camp staff.
2. Dress modestly in accordance with our current dress policy. Violation of this policy will not be permitted and campers will be sent home if they do not have appropriate attire.
3. All campers are expected to treat everyone with respect as their brother and sister in Christ. Therefore, any exclusive pairing off as a couple, or encouragement of this behavior (through talking about "crushes" or gossiping, etc.) or the formation of exclusive cliques is unacceptable and will not be tolerated.
4. Smoking, cigarettes, vaping, alcoholic beverages, drugs or other illegal substances, are not permitted.
5. Knives, lighters, matches, fireworks, firearms, and other dangerous items or weapons of any kind are not permitted. CSME reserves the right to search a camper's or staff's belongings if any of these items are suspected to be in their possession and will confiscate such items. At the discretion of the Camp Director, these items may be disposed of or returned to the camper's parents upon departure from camp.
6. Fighting is not permitted, including rough housing which might damage property or hurt smaller campers.
7. Swearing will not be tolerated.
8. "Raiding" of cabins is not permitted.
9. NO pranks of any kind will be allowed—on your cabin mates, other cabins, siblings, etc.
10. Taking anything that is not yours without permission is stealing and is not permitted
11. We respect camp property as well as the property of others. No defacing or destruction!
12. All medications including prescription, OTC, and supplements must be given to the medical staff at Registration.
13. Fire alarms and extinguishers are for emergency use only.
14. No pets or animals are allowed at camp.

# Camper Rules and Expectations

15. No electronic items allowed at camp except for Kindles that do not have internet browsing

16. No cameras of any kind.

*CSME is not responsible for the loss or damage of any electronic items. If such items are found to be in use, they will be removed from the camper's possession until departure time. We STRONGLY encourage campers to leave all electronic items at home.*

17. Campers are not permitted to have cell phones at camp. Camp is a time to "disconnect" from the everyday world and connect with nature, God, and our brothers and sisters in a unique Orthodox

Christian camp community. All cell phones will be collected upon check-in on Sunday, and stored until departure

18 No sports equipment of any kind.

19. Displays of physical affection between boys and girls will not be permitted. This includes: prolonged hugging, kissing, sitting on laps, hand-holding, and/or any other such displays that staff determine is inappropriate. Depending upon the severity of such displays, campers may be immediately dismissed from camp.

**Please Note:** While all disciplinary action will be taken to attempt resolution on site, the Camp Director reserves the right to dismiss campers for serious violations of camp rules. Parents will be responsible for arranging and covering costs for their camper's early departure which must take place within 10 hours of camper dismissal.



# Camper Dress Code and Packing List

## Dress code and Modesty Expectations

Parents, please make sure that your camper respects the dress code and packs appropriate clothing in accordance with Orthodox Christian values.

Campers wearing inappropriate clothing in violation of the CSME Dress Code Policy will immediately be asked to change. If a camper does not have proper attire in which to change, parents will be contacted by the Camp Director to arrange for delivery of dress-code-appropriate clothing.

This process can be disruptive and upsetting for your camper so please take the time to ensure that you and your camper are aware of the dress code policy and pack accordingly. Clothing that violates the dress code in any way should NOT be packed.

## Inappropriate clothing (clothing in violation of the dress code policy) includes:

leggings intended to be worn as pants are not allowed at camp, open back tops, tops with low-cut fronts, too-tight clothing of any kind, biker/spandex shorts of any kind, shirts that expose the midriff, thin/spaghetti-strap tank tops, short shorts (shorts should be worn a few inches above the knee), jean shorts with holes/rips, sagging jeans that expose underwear/boxers, clothing bearing inappropriate logos, sayings, or advertising, excessively ripped jeans and/or jeans that with holes that expose skin of the upper legs, bikinis, speedos, and costumes of any kind.

# Dietary and Health

## **Campers with Dietary Issues**

If your camper has a life-threatening food allergy and/or medical need for a special diet, please note it on the health form.

Aldersgate can also accommodate certain dietary restrictions (gluten-free or dairy free), but all meals are served buffet style and those campers with dietary restrictions must be able to advocate for their own diet as special dietary meals are served at a separate window.

For campers' safety, our policy at CSME is that campers who cannot advocate for their special diet will not be able to attend camp until they are mature enough to do so. This policy is not intended to be restrictive, but rather to protect those younger campers who cannot manage their own diets. The food environment at camp requires that a camper knows what he can and cannot eat and has the ability to ask for substitutes when needed.

**Please note:** *Unless your camper has an actual medical need for a dietary restriction, we ask that you not request a special diet—it creates a great amount of unnecessary work and expense for the kitchen staff for diet "preferences".*

If your camper has dietary issues, please email the Camp Director to discuss options.

## **Health Care**

You and your camper must complete the Health History, Health Profile, Authorizations, and Permissions in their entirety. These forms must be completed along with your camp registration in order to secure your camper's spot at camp. The Camp Nurse or Doctor reviews all Health Forms prior to camp, and is in residence for the entire camp session to handle routine and minor health care needs. Parents of campers with special medical needs that require extra and/or specialized medical care that falls outside the scope of routine/minor health care needs will be required to stay onsite for the duration of camp. Please refer to the Health Form regarding emergency medical care.

Campers

who present to the Medical Director at any time during camp with a fever of 100.4 degrees or higher, with lice, or with any other illness the Medical Director determines requires departure from camp, will be kept comfortable in the medical cabin while their emergency contact is notified. Arrangements must be made by the parent for camper pick-up within 10 hours of notification. Please make sure that you have a plan in place to pick up your camper from camp within 10 hours in case of emergency.

## **Health Insurance**

All campers must be covered by a medical insurance policy. While Camp St Mary of Egypt will act as guarantor, any costs incurred by CSME in providing required treatment for doctor's appointments, prescriptions, urgent/emergency medical care, etc., will be billed to the camper's parents or guardians.

# Life at Camp

## Living Arrangements

There are two types of cabins at Aldersgate. The A-frames house from 6 to 8 campers and are grouped in pairs for the duration of camp. There will be two counselors per cabin pairing. The larger cabins house between 10 to 12 campers and 2 counselors. Campers are grouped according to age and gender. While we do accept roommate requests, these are not guaranteed. Please Note - we are unable to accommodate requests for campers with an age difference of two years or more. One of the best aspects of the camp experience is learning to adjust to group living, making new friends, and getting along as part of a team!

**Note:** Campers ages 14-and-older are housed separately than campers ages 13-and-younger. As such, we will not be accommodating roommate requests for campers in the 13-and-younger group to be paired with campers in the 14-and-older group. Please also remember that all roommate requests must be submitted via the Camper Portal.

## Meals and Fasting

Meals are served buffet style in the cafeteria. The servings are generous and there are always second helpings available. Fasting rules are observed on Wednesday and Friday (no meat or dairy). For those campers with dietary issues, please see the section on dietary issues.

## Camp Activities

**Morning Education Sessions** in which the campers are divided up into age groups for in-depth teaching sessions with clergy that include: teachings by the priests on the focus topic of the day, "Fire on Father", stories from the saint's lives, exploring the Bible in depth, a service cra , and service to the Church.

**Fun Activity Sessions (FACT)** that include: rock climbing, giant waterslide, basketball, inner tube creek float, carpet ball, human foosball, basketball, pickleball, cra s, and more!

**Team Activities** include exciting activities, scavenger hunts, fun team challenges, and whatever other creative activities our talented Activities Director chooses!!

**Evening Program** features things like campfires with singing, the ever-popular talent show, dances, and other surprising activities brought to you by our talented Activities Director!

## Visiting Camp

You will have the opportunity to meet our staff and tour the camp facilities on Friday during registration. However, because campers often become homesick when they see a parent or family member, we ask that there be no other visits to camp during the regular camping session. No unauthorized visitors are allowed at CSME during the entire duration of camp.

## Contact With Your Camper

The active camp schedule prevents regular contact with your camper. Outgoing calls may be allowed at the discretion of the Camp Director, and only for urgent matters. Receiving or placing phone calls during the camp session disrupts the program and often makes homesickness worse, so we do not allow them except for emergencies. Letters are okay to send but please do not send care packages that contain food as it is not allowed in cabins and we cannot store it for your camper.

If your camper suffers serious injury or illness, you will be notified promptly. Below is a list of when you'll be notified by CSME

# Life at Camp

## CSME "Parent Notifications"

Parents will be contacted by the Medical Director or the Camp Director and may be asked to pick up their camper in the event of:

- Pre-Camp - Health Profile/History deficiencies or concerns
- Camp—Health Profile/History incomplete, or parental permissions not granted
- Camper medical emergency
- Medical outcome of treatment
- Non-emergency diagnostic services, rehabilitation services or specialist services are needed
- If a camper presents to the MD for a health complaint and previous permission was not given for administering stock medications
- The discretion of the Medical Director due to camper illness
- Fever of 100 degrees or higher
- Lice found on camper
- Serious violation of the rules
- At any time, to relay information about their campers physical or mental health, or other incidents of concern as deemed necessary by the Medical Director or Camp Director

Should a serious need to communicate with your child arise, please contact Kh Kara Vollman at 425.420.8778 or call Aldersgate directly at 503.743.2494 during normal business hours.

## Media Consent

Throughout your camper's stay, staff members will be taking photos for the final evening's photo slideshow (a highlight of the week!). There will also be a camp photo that will be displayed on the camp website. Please know that all staff members have signed a "CSME Volunteer Staff Policy for Social Media and Websites" and take your camper's privacy seriously. By sending your child to Camp St Mary of Egypt, you are giving permission for their photo to be on the camp website.

## Sending a First-Time Camper

If this is your child's first trip to Camp St Mary of Egypt, your preparation in advance will go a long way towards helping them have a great experience and minimize the effects of homesickness. Please visit the Parent Resources section of our website for a link with tips from the ACA on preventing homesickness.

We do ask parents to consider carefully whether their child is ready for camp. In our experience, we have found that if a child is hesitant about attending camp or does not yet seem ready, it is often in the child's best interest to wait a year. It is better to wait one year and have a camper have a positive experience, than to come too early to camp and be left with a lasting negative impression. Readiness to attend camp varies widely, especially among 9- to 12-year-olds, so please take your own child's temperament and social maturity into consideration.

# CSME Summer Camp 2026 Camper Dress Code

We have received many questions pertaining to camper dress code while at CSME Summer Camp. Below is an updated guideline to assist you and your camper with packing. Please read the following carefully with your camper. **It contains pertinent information including our Dress Code Violation Policy.**

## Why a Dress Code Policy?

Every day while at Camp St. Mary of Egypt, campers participate in Church services, spiritually edifying discussions, concentrated time with clergy that includes opportunities for confession, and activities geared around fun and fellowship with their Orthodox peers. Thus, while we recognize that camping is of its nature informal, Christian modesty should be the guiding principle when packing for CSME Summer Camp. Please take the time to carefully read the following guidelines with your camper to ensure that expectations are clear on what is appropriate to pack for camp.

## What TO Wear

**Daily wear:** the best clothes to pack for daily wear at camp are a loose-fitting t-shirt and either long pants, capris, long shorts, or knee-length-or-lower skirts.

**Swimwear:** Girls: One-piece swimsuits, tankinis, or swim shorts that cover the midriff. Boys: Swim trunks that fit well at the waist (be mindful of length and fit)

**Church Service Attire:** for daily services, camp clothing is fine, although sleeveless shirts are never allowed during church services (either boys or girls). We will have Divine Liturgy once during the camp week, and for that we ask that you pack one nice "church" outfit—Dress, skirt, or dress pants with a blouse for girls, slacks/dress pants (no jeans) and a nice shirt for boys. There will be time to change into regular "camp clothes" after breakfast on Liturgy day.

**Footwear:** part of the fun of camp is all the activities and you need to wear the right shoes. Close-toed shoes are a must for all Activity Sessions and Team Time Activities. Sneakers, athletic shoes, or water shoes with a back-strap are best (flip flops are best kept for showers).

**Weather and Cool Evenings:** It is generally in the 80's during the summer season. Evenings can be cool, so layers are a must. Especially since many of our evening/night activities are outside and campers who are not layered tend to get cold.

## What NOT to Wear

Clothing is **NOT CSME Camp-appropriate** for campers of any age:

**Tops:** Open back tops, low-cut fronts, skin tight tops, spaghetti-strap, racer-back, and thin strap tank tops, and mesh or undershirt tank tops will not be permitted. **The neckline of all tops/dresses must be high enough so that absolutely no cleavage is showing.**

**Swimming Attire:** Bikini bathing suits (**tankinis are permitted as long as the midriff is completely covered**), speedos, and sagging or skintight swim trunks will not be permitted. **NEW - Boys must wear shirts at all times including water activities!**

**Dresses:** Hem must hit at knee length or below. **This applies to both services AND the camp dance**

**Bottoms:** Shorts cut shorter than a few inches above the knee or shorts with any rips in them or holes in them will not be allowed at camp. Low-cut waistlines, and sagging shorts that expose boxers/underwear will not be permitted.

**Leggings worn as pants are not permitted at camp (leggings may be worn under a dress for services). REGARDLESS OF CAMPER AGE**

Jeans with tears above the knee that expose skin will not be permitted. Note that shorts with any tears/rips of any kind are not allowed at camp.

**Images/Logos/Wording:** Clothing items or other personal items that contain inappropriate language, images, logos, pop icons and/or any messages not in line with traditional Orthodox teachings will not be permitted.

**Body Piercings/Tattoos:** Excess earrings and other body piercings must be removed prior to admittance to camp. Tattoos should be covered at all times while at camp to the best of the camper's ability.

**Hats:** Baseball caps and beanies, while acceptable to wear when engaging in camp activities, will not be permitted during Church services.

## Dress Code Violations

Any camper wearing attire that blatantly violates the Dress Code Policy set forth above, will be immediately escorted to his/her cabin to change by either his/her counselor or the Camp Director. If the camper has not packed alternative, camp-appropriate attire in which to change, the Camp Director will contact his/her parent/guardian and ask that they bring appropriate attire to the camper. Campers may not return to normal camp activities until they are dressed appropriately. **Repeated violations of dress code policy will result in dismissal from camp.**

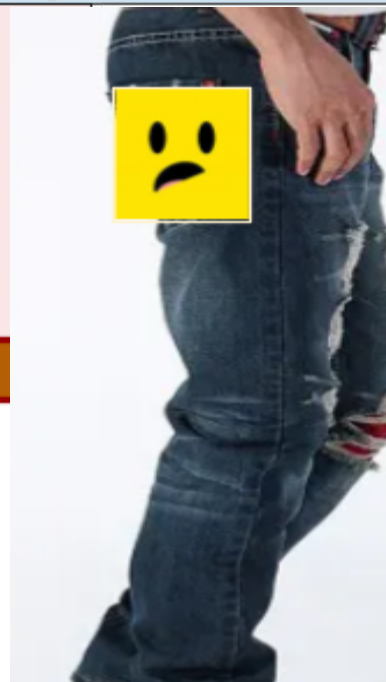

*Acceptable lengths for Camp*

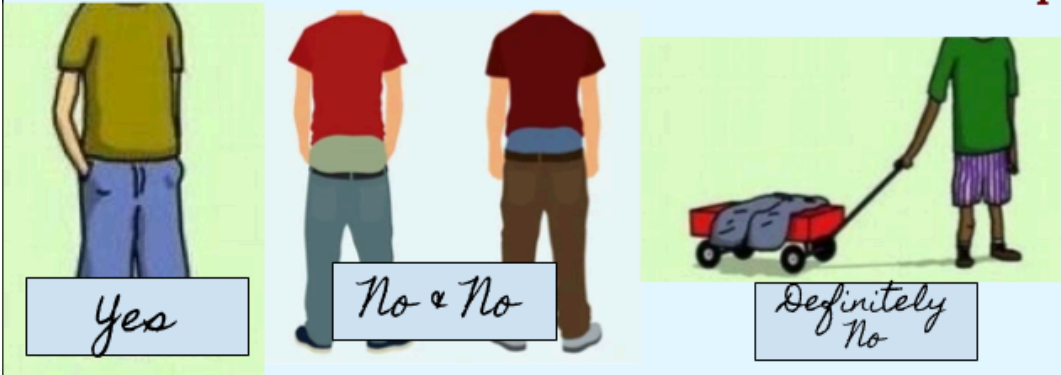

#### A Guide for CSME Summer Camp Worn Jeans



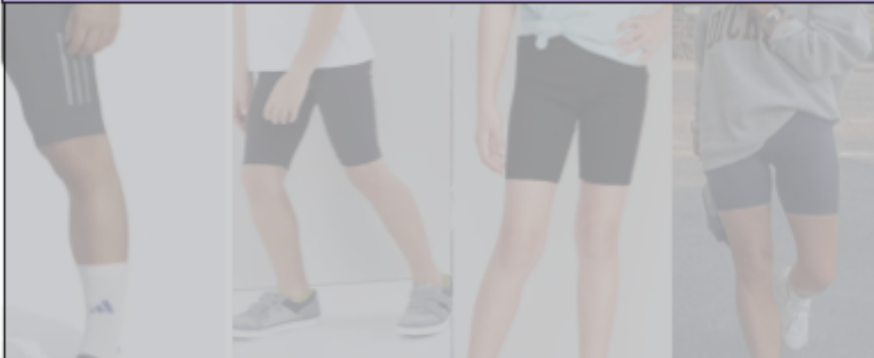

## Bridle the Biker Shorts

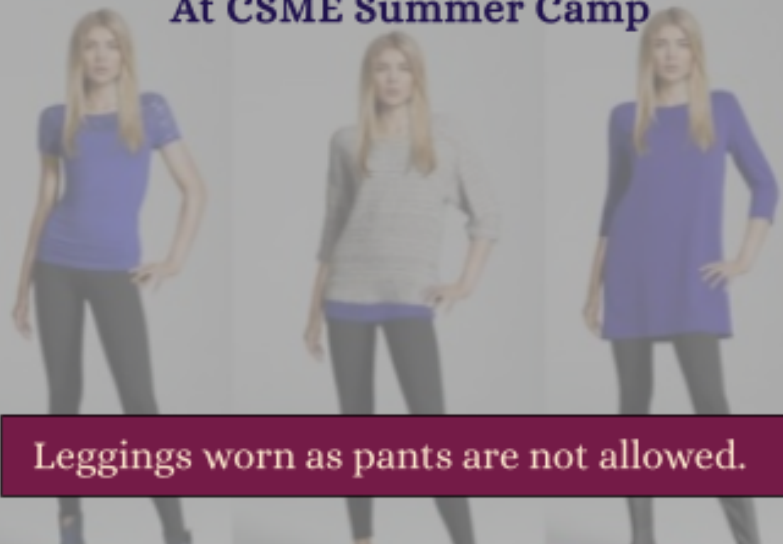
